Item 4: Kommune or City, Country

Items 5, 13, and 18: Date format should be written as follows: Day Month Year (ex: 1 January 2000). Always spell out the month

Item 7: Indicate whether single, twins, or triplets, etc.

Item 8: Birth order of the child, counting all children born by mother, including fetal death

Items 9-11: Under the mother's maiden information, kindly enter the name when still single, as written in the birth certificate.

Item 14: The husband's/wife's place of birth should be the same as what is written in their Philippine passport.

Item 16: Kindly <u>leave blank</u> if father and mother were born to Filipino parent/s. Answer only if either parent is a naturalized Filipino.

Item 19: Indicate the place of marriage in the PSA Marriage Certificate or ROM
